	Low density residential single-family detached dwellings w/min. 15,000 sqft lots
R-10	Neighborhood Residential
	Residential single-family detached dwellings w/ minimum 10,000 sqft lots
R-10A	Single-Family Residential
n -	Residential single-family detached manufactured housing w/ minimum 10,000 sqft lots
R-7	Small-lot Residential
	Residential single-family detached dwellings w/ minimum 7,000 sqft lots
R-D	Single-Family and Duplex Residential Residential single-family duplex dwellings w/ min. lot 7,000 sqft per unit
RA-12	Single-Family Attached & Detached Residential
NA-12	Single-family attached & detached dwellings maximum twelve (12) dwelling units per acre
RSL	Residential Senior Living
NOL	Single-family attached & detached dwellings for adults age 55 and older
MF-14	Multi-Family Residential
	Multi-family residential uses maximum fourteen (14) dwelling units per gross acre

	Professional and Medical offices as well as financial establishments
N-C	Neighborhood Commercial Areas for limited commercial uses (retail, services, offices) in close proximity to residential districts

0-0	Office, restaurant, retail, and service establishments
DBD	Downtown Business District
	Variety of services and offices, also residential w/in commercial and office buildings

	Variety of commercial including retail, office, automotive, and service establishments

	Industrial that does not emit noise, odor, smoke (distribution, warehouse, processing)
