2 INSTRUCTIONS TO BIDDERS

- 1. To be considered, RFB'S must be in the possession of the City of Cartersville prior to the time of the RFB Closing. RFB'S may be mailed or delivered to the office of Tom Gilliam, Director Parks & Recreation, City of Cartersville, PO Box 1390, 100 Pine Grove Road, Cartersville GA 30120, in a sealed envelope clearly marked as to the item being bid and also marked with the time and date of RFB Closing. Regardless of the method the BIDDER uses to deliver the RFB, each Bidder shall be responsible for the RFB being delivered on time; as the City of Cartersville assumes no responsibility for the same. Bids offered or received after the time set for RFB closing will not be considered. Questions regarding the RFB must be submitted via email and sent to tgilliam@cityofcartersville.org.
- 2. No Bid may be withdrawn for a period of 30 days from the RFB Closing Date.
- 3. All RFB's are to be submitted on the "Bid Form" provided in this RFB Package, and signed by an authorized representative of the company placing the Bid. Two (2) complete sets of RFB Documents shall be furnished to each company or person interested in submitting a Bid. One set of the RFB Documents, including the "Request for Bids", "Instructions to BIDDERS", and "Bid Form", all attached hereto, shall remain intact and be returned as an integral part of the RFB. The second copy is the Bidder's file copy. Included with the RFB, the Bidder shall submit material specifications and/or product bulletins clearly marked for proof that the material item(s) the Bidder proposes to provide will meet or exceed the requirements of the Specifications.
- 4. The City of Cartersville is exempt from Federal, State, and Local Taxes. Taxes incurred by the Contractor during this project shall be to the account of the Contractor.
